# Department of Labor Proposes New Definition of Nonexempt Worker

On June 30, the Wage and Hour Division of the U.S. Department of Labor proposed to update the current regulation that defines which executive,



administrative and overtime employees are entitled to the Fair Labor Standards Act's minimum wage and

overtime pay protections. The proposed rule focuses primarily on updating the salary and compensation levels needed for white collar workers to be exempt.

DOL took action in response to a March 2014 memorandum from President Obama which directed the Department "to propose revisions to modernize and streamline the existing overtime regulations." Since then, DOL has met with multiple stakeholders, including ASA, to discuss how best to move forward on the President's directive. This proposed rule shows why we need an association to represent us at the national level. ASA was able to discuss problems with the current definition and to suggest ways to define the differences between exempt and nonexempt employees to help employers both understand the differences and to comply with the rule.
